## **Directions**

***From 695 East/West:*** Exit 32B (Belair Rd., North), Merge onto US1N/ Belair Rd toward Bel Air. Proceed approximately 3 miles and turn right onto Ebenezer Road. Active Life and Sports is located in Perry Hall Square, on the right-hand side of Ebenezer Road. Storefront location is in between Rite-Aid and the Dollar General.

***From 95 North/South:*** Exit 67B, Merge onto MD 43 West, (Whitemarsh Blvd) toward US1 West (Belair Rd.) Bear right toward Ebenezer Road. Turn left onto Ebenezer Rd. Active Life and Sports is located in Perry Hall Square, on the left-hand side of Ebenezer Road. Storefront location is in between Rite-Aid and the Dollar General.
